- holding at least 10% of shares or stocks, unless a lower threshold results from the provisions of the law or has been specified in other documents related to the project,
- being a member of a supervisory or managing body, a proxy, a representative,
- being married, in a relationship of consanguinity or affinity in a direct line, or in a relationship of consanguinity or affinity in the collateral line to the second degree, or in a relationship of adoption, custody or guardianship, or in cohabitation, his legal deputy or members of the management or supervisory bodies of the economic operators competing for the award of the contract,
- remaining in such a legal or factual relationship that there is reasonable doubt as to their impartiality or independence in relation to the procurement procedure.
- f) the circumstances indicated in:
- Article 5k of Council Regulation (EU) No. 833/2014 of 31 July 2014 concerning restrictive measures in view of Russia's actions destabilising the situation in Ukraine (Official Journal of the EU No. L 229 of 31.7.2014, p. 1),as amended by Council Regulation (EU) 2022/576 amending Regulation (EU) No 833/2014 concerning restrictive measures in view of Russia's actions destabilising the situation in Ukraine (Official Journal of the EU No. L 111 8.4.2022, p. 1),
- in Article 7(1) of the Law of 13 April 2022 on specific solutions to counter support for aggression against Ukraine and to protect national security, for the duration of these circumstances,
  - do not pertain the Bidder.
- g) The Bidder shall be deemed to be bound by the Bid for a period of minimum 90 days,
- h) The persons signing the Bid Form are authorised to submit a bid on **behalf of the Bidder**.
